CURRENTLY Abortionist Mila Means has nowhere in Wichita to perform her abortions. After she announced her plans to begin performing them at the same location as her family practice (9916 E. Harry St., Wichita, KS), the landlord sought an injunction to prevent her from doing so. We recently learned that after retaining George Tillers old attorney (Clinton Appointee) Lee Thompson to represent her, *has now decided not to fight the landlord and has agreed to move.*



We have also learned that Means gave a letter of intent to lease a location at 446 Delrose. Once the owners found out about it what she was going to use it for, they told Means... no way!

- "The lawsuit said Means' plans to begin offering abortions later this year **already have prompted protests at the building. (most of the time all 3 of us (one time we had 12 or so))**"
- "*The lawsuit said three tenants have announced plans to leave the building if the protest continues.*"
- "**The intermittent presence of demonstrators, protesters and police officers is unsettling (pretty unsettling to the unborn child also, I should think)** to my staff and to clients visiting my office."
- "**Protestors have staged demonstrations at Means' clinic since The Associated Press story...**"
- "The landlord contends performing abortion in the multi-tenant building would **be a disruption and nuisance to other tenants...(well, I've been called worse :))**"
- "...three tenants have notified the landlord of their intention to vacate their leased premises **due to the anticipated (they anticipated well) nuisance of daily protests...**"
- "*Foliage contended it would lose substantial revenue from tenants vacating the office building and would have difficulty leasing space if abortion were performed on the premises.*"
- "Andrea Hamel, office manager for Means' family practice, on Thursday referred comment to Kari Ann Rinker, state coordinator for the National Organization for Women. **Rinker blamed anti-abortion groups, which she said have been ratcheting up their rhetoric and encouraging harassment of Means. (being confronted with ones own sins can be pretty "harassing.")**"
- "She is within her rights to practice her medicine at this facility, **but the intimidation from the other side forces us to have to pay the price and the community needs to stand up and be held accountability when something like this occurs, (we could not agree more!)**" Rinker said. "We failed to do that adequately for Dr. Tiller. I don't plan to fail this doctor."
